Key Messages

- Governance complexities of city planning and management vis-à-vis cities' challenges climate change, increasing population density and related issues such as housing needs, traffic congestion, pollution, access to clean water and sanitation; if not addressed environmental degradation and loss of biodiversity
 - Coordination and transparency
 - Political commitment
 - Garnering multi-stakeholder participation
 - Economic impact of policies and programmes
 - Local autonomy over environmental issues
- Partnerships 3P (Public, People and Private) Sectors
 - Examples: Sibu/ Private & Public Sector; Puerto Princesa/ People; Waitakere/ People

 Value of sharing experiences and best practices – learning from others - approaches, techniques, tools, methods

- Retrofitting stream habitats (Waitakere)/ Riverbank Rehabilitation (Puerto Princesa)
- Greenfield concept planning (Waitakere)
- Watershed based planning (Bandung)
- Vertical development (Bandung)
- Ecological network approach (Bandung)
- Smart Partnerships private sector; national govt (Sibu)
- "Protect, Rehabilitate, Plan" Management Plan (Puerto Princesa)
- Puerto Princesa Watch includes the Forest and Bay Watches

Key Messages ... (3)

Continuation of Examples

- Developing a biodiversity strategy/ plan (Waitakere, Bandung, Nagoya)
- "One Village, One Playground" (Bandung)
- Urban Agriculture (Bandung)
- Awareness (all cities employing different approaches)
- Evaluation tool (self-assessment) for cities' biodiversity conservation efforts - City Biodiversity Index
- Sharing our experiences with a wider network City Biodiversity Summit, Global Partnership on Cities and Biodiversity under the Convention on Biological Diversity (CBD) Framework, ICLEI-LAB, etc.
- Importance of engaging cities and local authorities in biodiversity conservation - increasing recognition at the global level (Decision IX/28 of the CBD). At COP-10, a draft decision to be considered on Cities, Local Authorities and Biodiversity, which includes a draft Plan of Action
